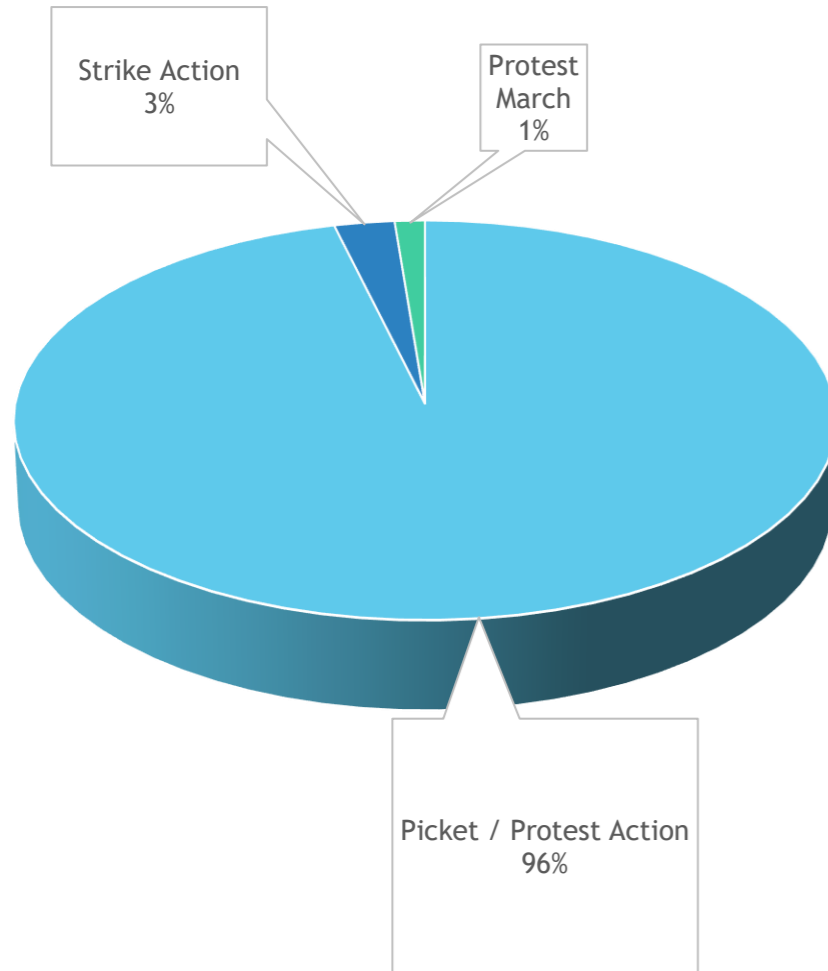

TopicWorx Alerts – Anticipated Events

The below section highlights unrest reported by TopicWorx to the CGCRI, which have been reported over the course of the week

- Demonstrations expected at the Johannesburg Magistrate Court (Ferreiras Dorp, Johannesburg, Gauteng) on 07/08/2020 regarding dissatisfaction with approved bail – travel and security risks foreseen.
- SAMWU strike action and/or demonstrations anticipated in several municipalities in Gauteng from August 2020 owing to dissatisfaction with the non-payment of salary increases – operational risks foreseen.
- Industrial action expected at Denel Head Office in Irene (Centurion, Gauteng) from 07/08/2020 pending payment of wages – risks to business operations foreseen.
- Demonstrations by members/supporters of COSAS anticipated at schools nationwide from August 2020 due to dissatisfaction with reopening of schools – risks to business operations expected.
- Demonstrations expected at the Hartswater Magistrate Court (Hartswater, Northern Cape) on 13/08/2020 relating to court proceedings of murder suspects – travel and security risks foreseen.
- Taxi related unrest foreseen in Rosettenville (Johannesburg South) and Kensington (Johannesburg, Gauteng) from August 2020 relating to dissatisfaction with taxi violence – travel and security risks anticipated.
- Demonstrations anticipated to the Morebeng Magistrate Court in Motetema-A (Motetema, Limpopo) on 07/08/2020 during court proceedings of murder accused – travel and security risks foreseen.

- CGCRI Armed Robbery, 2020/08/01, 19:00. Pick n Pay Azaleapark, Rustenburg, NW. 7 Suspects. Entered the store and demanded cash from the tills and cash office. Suspects removed cash and fled the scene. No shots fired or injuries reported.
- CGCRI Armed Night Robbery, 2020/08/04, 06:00. Rhino Cash & Carry, East London, EC. 3 Suspects. Held up security and gained access to the store. Suspects demanded SASSA cash. Suspects removed cash and fled the scene. No shots fired or injuries reported.
- CGCRI Burglary, 2020/08/06, 00:10. Cambridge Food Seshego, Polokwane, LP. Unknown suspects. Entered the store through the roof. Removed cash and cigarettes from the cash office. Fled the scene. No shots fired or injuries reported.
- CGCRI Armed Robbery, 2020/08/06, 07:30. Boxer Libode, Libode, EC. 2 Suspects. Entered the store and demanded cash from the safe. Suspects removed cash and exited the store. A security guard was shot and injured. The suspects fled the scene.
- CGCRI Armed Robbery, 2020/08/06, 09:00. Pharmacy at SPAR Moreleta Square, Pretoria, GP. 2 Suspects. Entered the store and demanded cash from the tills and safe. Suspects removed cash and fled the scene on foot. No shots fired or injuries reported.
