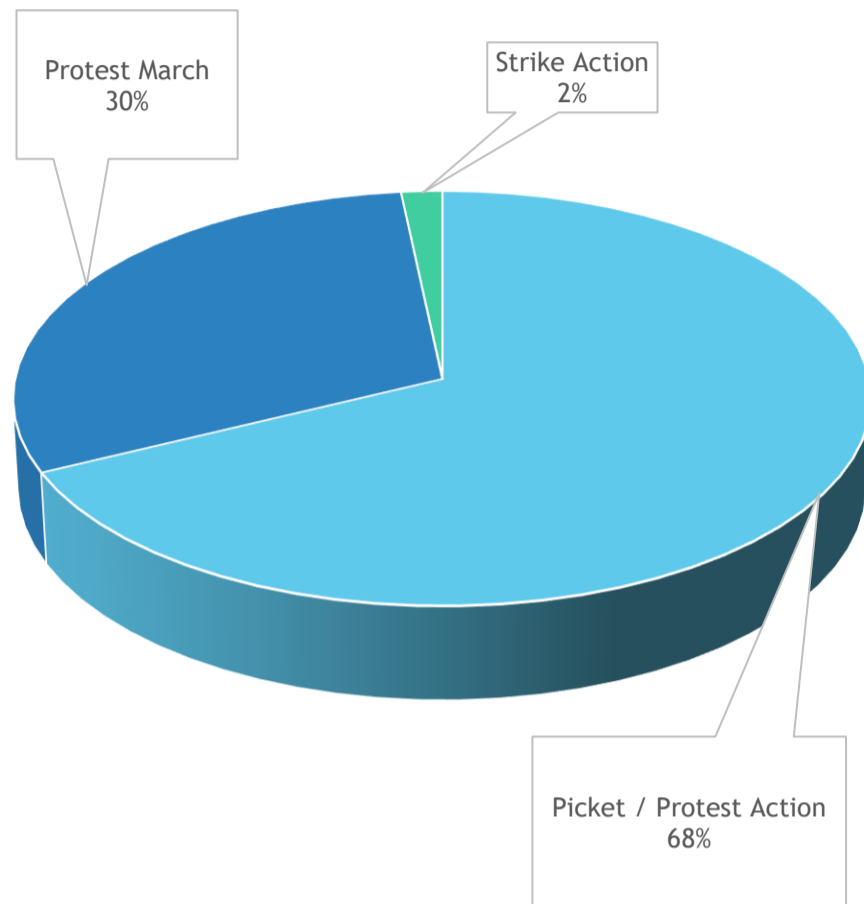

TopicWorx Alerts – Anticipated Events

The below section highlights unrest reported by TopicWorx to the CGCRI, which have been reported over the course of the week

- Service delivery related protest action anticipated in Sunway (Hartbeespoort, North West) from August 2020 – travel and security risks foreseen.
- Protest action anticipated along Main Reef Road/R29 in/near Comet (Boksburg, Gauteng) from August 2020 owing to labour related grievances – travel and security risks foreseen.
- Demonstrations by Uber drivers anticipated on several major roads in City of Cape Town Metropolitan Municipality (Western Cape) from August 2020 – risks to business operations foreseen.
- Demonstrations anticipated at the Western Cape DAFF Head Office in Cape Town Central (Western Cape) from August 2020 owing to dissatisfaction with supposed economic exclusion – risks to travel and security foreseen.
- Court proceedings for former President Jacob Zuma anticipated at Pietermaritzburg High Court (Pietermaritzburg Central, KwaZulu-Natal) on 08/09/2020 – demonstrations anticipated to result in risks to business operations.
- Risks to travel and security anticipated in Brakpan Central (Gauteng) from August 2020 owing to dissatisfaction with possible evictions attempts.
- Demonstrations expected at Nelson Mandela Bay Metropolitan Municipal Head Office (Port Elizabeth Central, Eastern Cape) from August 2020 owing to several grievances – risks to travel and security anticipated.
- Protest action relating to illegal occupation of RDP houses anticipated in Clayville (Olifantsfontein, Gauteng) from August 2020 – risks to business operations foreseen.
- Travel and security risks foreseen during anticipated protest action in Riverlea (Johannesburg, Gauteng) from August 2020 owing to dissatisfaction with mining operations.
- Court proceedings of Nathaniel Julius murder accused to result in demonstrations at the Protea Magistrate Court (Protea North, Soweto, Gauteng) on 10/09/2020 – risks to business operations likely.
- Demonstrations anticipated at Cape Town Magistrate Court (Cape Town Central, Western Cape) on 13/10/2020 during court proceedings – risks to travel and security anticipated.
- Risks to travel and security foreseen at the Durban Magistrate Court (Stamford Hill, Durban, KwaZulu-Natal) on 10/09/2020 during court proceedings of former Executive Mayor of eThekweni Metropolitan Municipality – demonstrations probable.
- Motorcade demonstrations to the Union Buildings (Arcadia, Pretoria, Gauteng) expected on 05/09/2020 to raise awareness of farm murders – travel and security risks anticipated.
- Court proceedings of farm attack suspects at Morebeng Magistrate Court in Motetema-A (Motetema, Limpopo) on 04/09/2020 to result in demonstrations – travel disruptions and security risks foreseen.
- Travel disruptions and security risks likely during anticipated demonstrations at Ermelo Magistrate Court (Ermelo, Mpumalanga) on 18/09/2020 during court proceedings.

Amavuso Crime Alerts

The below section lists the CGCRI Amavuso Crime Alerts which have been distributed over the course of the past week

- CGCRI Attempted Armed Robbery, 2020/09/02, 19:05. Pick n Pay Carletonville, Carletonville, GP. Unknown suspects. Entered the store and the manager pressed the panic button. SAPS arrived and a shootout ensued. Suspects fled the scene.
- CGCRI CIT - Cross Pavement, 2020/09/02, 17:43. SPAR 1000 Hills, Botha's Hill, KZN. 5 African male suspects. Approached the G4S guard and removed a firearm and cash. Suspects fled the scene in a white Nissan Hardbody Double Cab, registration number ND872787. No shots fired or injuries reported.
- CGCRI CIT - On Merchant Premises, 2020/09/03, 07:14. Spar Panorama, Cape Town, WC. 2 Suspects. Entered the store and held up the CIT guard. Suspects removed cash from the cash office and exited the store. Cover CIT officer responded and was shot and injured. CIT driver was shot and fatally crashed the vehicle. Suspects fled the scene in a white Volkswagen Golf, registration number unknown.
- CGCRI Attempted Burglary, 2020/09/04, 01:30. Boxer Port Edward, Port Edward, KZN. Unknown suspects. Gained access through the receiving wall. Suspects fled the scene. No stock loss. No shots fired or injuries reported.
- CGCRI Attempted Burglary, 2020/09/04, 01:30. Boxer Bhamshela, KwaNgcongangeonga, KZN. 18 Suspects. Gained access to store and targeted the cash office safes. SAPS responded and a shootout occurred. Suspects fled the scene. No cash loss. 1 SAPS member fatally wounded. No injuries reported.
- CGCRI Burglary, 2020/09/04, 02:30. Boxer Schoemansdal, Schoemansdal, MP. Unknown suspects. Gained access to the store and used unknown explosives to gain access to the ATM and cash office safes. Suspects removed cash and fled the scene. No shots fired or injuries reported.
- CGCRI CIT - Cross Pavement, 2020/09/03, 17:10. Game Mitchell's Plain, Cape Town, WC. Unknown suspects. Arrived at the store and approached the CIT guard. Suspects removed SASSA cash and a shootout occurred. 1 CIT guard fatally shot and 1 staff member injured. Suspects possibly fled the scene in a white Volkswagen Polo and a yellow Toyota Hilux Hi-Rider, registration numbers unknown.
- CGCRI Armed Robbery, 2020/09/04, 06:00. Cambridge Bizana, Bizana, EC. Unknown suspects. Gained access to the store and demanded SASSA cash. Suspects removed cash and fled the scene. No shots fired or injuries reported.
