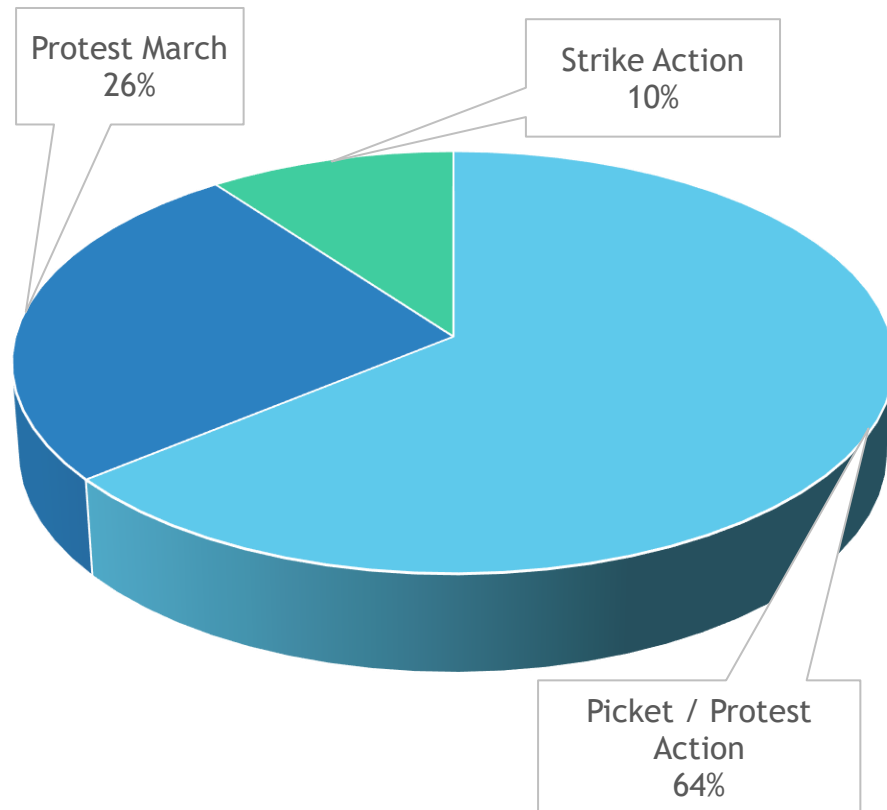

TopicWorx Alerts – Anticipated Events

The below section highlights unrest reported by TopicWorx to the CGCRI, which have been reported over the course of the week

- NUMSA strike action and/or demonstrations expected at BOC operations in Gauteng from 05/10/2020 owing to deadlocked wage negotiations – risks to business operations foreseen.
- NUM industrial action expected at De Beers, Seriti Resources, Exxaro Coal and Petra Diamonds operations in Mpumalanga, Free State, Northern Cape and Limpopo from October 2020 – risks to business operations anticipated.
- SAFTU and NUPSAW demonstrations anticipated at the DPSA Head Office in Arcadia (Pretoria, Gauteng) on 12/10/2020 to demand implementation of final year of Public Sector wage agreement – operational risks foreseen.
- SACTWU industrial action anticipated in the Textile Industry nationwide from October 2020 owing to deadlocked wage negotiations – risks to business operations foreseen.
- Court proceedings expected to result in demonstrations at Bloemfontein Magistrate Court (Bloemfontein Central, Free State) on 11/1/2020 – risks to travel and security expected.
- Risks to business operations anticipated during expected demonstrations at Murraysburg Magistrate Court (Murraysburg, Western Cape) on 19/10/2020.
- Demonstrations anticipated at the Kgapane Magistrate Court (Ga-Kgapane-A, Modjadjiskloof, Limpopo) on 14/10/2020 during proceedings of sexual assault accused – risks to travel and security foreseen.
- Demonstrations anticipated at WCED Overberg District Office (Caledon, Western Cape) from October 2020 owing to demand for scholar transport – travel and security risks expected.
- NEHAWU demonstrations anticipated from October 2020 at NSFAS offices nationwide – operational risk foreseen.
- Operational risks foreseen at Maitland Police Station (Maitland, Cape Town, Western Cape) from October 2020 during anticipated protest action over dissatisfaction with the Station Commander.
- Housing related protest action anticipated in Lower Crossroads (Philippi, Cape Town, Western Cape) from October 2020 – travel and security risks foreseen.
- Demonstrations expected at UFH Alice Campus (Alice, Eastern Cape) from October 2020 pending outcome of sexual assault investigation – risks to business operations anticipated.
- Demonstrations against farm murders expected at Delmas Magistrate Court (Delmas, Mpumalanga) on 13/10/2020 – risks to business operations anticipated.
- Demonstrations expected at the Bronkhortspruit Magistrate Court (Erasmus, Bronkhorstspuit) and the Union Buildings (Arcadia, Pretoria, Gauteng) on 09/10/2020 and 10/10/2020 to raise awareness of farm murders – operational risks foreseen.
- Demonstrations expected at Bloemhof Magistrate Court (Bloemhof, North West) on 14/10/2020 during court proceedings of murder accused – risks to business operations anticipated.
- EFF demonstrations expected at the Randburg Magistrate Court (Bryanbrink, Randburg, Gauteng) on 13/10/2020 during court proceedings of Julius Malema – travel and security risks foreseen.
- Dissatisfaction with amendments to the DVA to result in demonstrations at the Parliament of South Africa in Cape Town Central (Western Cape) from October 2020 – risks to travel and security foreseen.
- Demonstrations anticipated in Paul Roux (Free State) on 16/10/2020 during court proceedings of farm murder accused expected to result in risks to travel and security.

- CGCRI CIT - Cross Pavement, 2020/10/05, 05:59. Mega SPAR, Pinetown, KZN. 7 Suspects. Approached the Fidelity guard as he was exiting the store. Suspects removed cash and fled the scene in a white Toyota Hilux (Single Cab), registration number unknown. Security guard shot and injured.
- CGCRI Armed Robbery, 2020/10/05, 09:30. Pick n Pay Mabopane Lifestyle, Mabopane, GP. 2 Suspects. Suspects entered the store and demanded cash. Suspects removed SASSA cash and the store's camera system and fled the scene. No shots fired or injuries reported.
- CGCRI Armed Robbery, 2020/10/06, 12:10. Masscash Liquor Witbank, Emalahleni, MP. 6 Suspects. Entered the store and demanded cash from the tills. Suspects removed cash and fled the scene on foot. Shots fired and no injuries reported.
