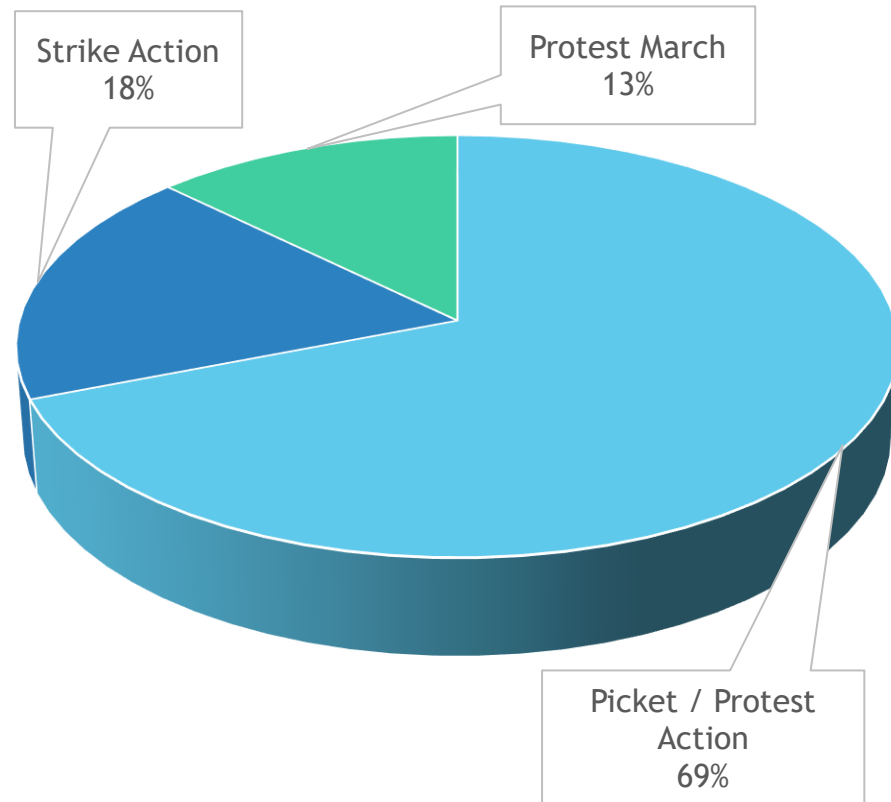

TopicWorx Alerts – Anticipated Events

The below section highlights unrest reported by TopicWorx to the CGCRI, which have been reported over the course of the week

- Service delivery related protest action expected in Promosa (Potchefstroom, North West) from October 2020 – operational risks anticipated.
- COSATU strike action and/or demonstrations anticipated nationwide from 22/10/2020 owing to several grievances – risks to business operations anticipated.
- Travel disruptions foreseen in Bluff and Sydenham (Durban, KwaZulu-Natal) on 17/10/2020 during anticipated demonstrations against child trafficking.
- Court proceedings of murder accused expected to result in demonstrations at Vereeniging Magistrate Court (Vereeniging, Gauteng) on 20/10/2020 – operational risks foreseen.
- Risks to business operations likely during anticipated demonstrations at the Blue Downs Magistrate Court (Blue Downs, Cape Town, Western Cape) on 19/10/2020 during court proceedings of murder accused.
- Court proceedings of murder accused to result in demonstrations at the South Gauteng High Court in Johannesburg Central (Gauteng) on 20/10/2020 – risks to travel and security foreseen.
- Demonstrations anticipated at the Pretoria Magistrate Court in Pretoria Central (Gauteng) on 19/10/2020 during court proceedings following malicious damage to property to Tshwane House infrastructure – risks to travel and security foreseen.
- NUPSAW industrial action anticipated at the National DPSA (Arcadia, Pretoria, Gauteng) from October 2020 owing to continued dissatisfaction with the non-implementation of the Public Sector wage agreement – operational risks foreseen.
- Risks to business operations expected during anticipated demonstration at the Regional City of Cape Town Metropolitan Municipal Office in Khayelitsha (Village 2 North, Khayelitsha, Cape Town, Western Cape) from October 2020.
- Protest action anticipated in Butterworth (Eastern Cape) from October 2020 due to dissatisfaction with lack of water – travel and security risks foreseen.
- Court proceedings of murder accused expected to result in demonstrations at Simon’s Town Magistrates Court (Simon’s Town, Cape Town, Western Cape) on 23/10/2020 – operational risks anticipated.
- Demonstrations expected at Pinetown Magistrate Court (New Germany, Pinetown, KwaZulu-Natal) on 23/10/2020 during court proceedings – risks to business operations foreseen.
- Travel disruptions foreseen in/near Meyerton (Gauteng) on 16/10/2020 during anticipated demonstrations relating to dissatisfaction with farm murders.
- Demonstrations by MKMVA anticipated in several areas in Gauteng and KwaZulu-Natal from October 2020 due to multiple demands/grievances – risks to business operations foreseen.
- Demonstrations anticipated in Senekal (Free State) on 16/10/2020 during court proceedings of farm murder accused – travel and security risks foreseen.
- SAMWU and Sol Plaatje Local Municipality reach wage increase agreement suspending strike action – additional industrial action in Kimberley (Northern Cape) remains probable from October 2020 pending implementation.
- Demand for adequate service delivery expected to result in protest action in Daveyton (Benoni, Gauteng) on 19/10/2020 – travel and security risks foreseen.
- Dissatisfaction with sexual assault expected to result in unrest in Kraaifontein (Cape Town, Western Cape) from October 2020 – operational risks anticipated.
- #PutSouthAfricansFirst demonstrations expected in Musina (Limpopo) on 16/10/2020 due to dissatisfaction with foreign nationals – risks to business operations anticipated.
