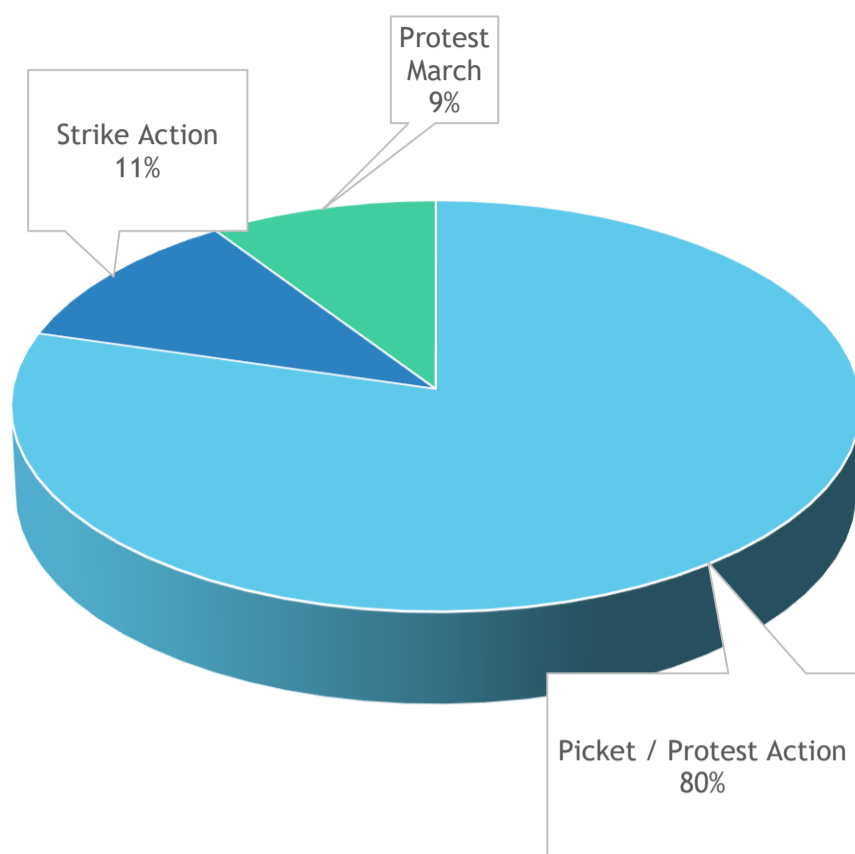

- Protest action anticipated near Pienaarsrivier (Limpopo) from November 2020 pending attempted illegal land occupation attempts - travel and security risks foreseen
- Demand for housing likely to result in protest action in Red Hill (Durban North, KwaZulu-Natal) from November 2020 - travel and security risks foreseen
- Travel and security risks foreseen during anticipated service delivery related protest action in several areas in Bethlehem (Free State) from November 2020
- Risks to travel and security foreseen during anticipated protest march by EFF to Z22 Farming operations in Mooketsi (Limpopo) on 27/11/2020
- EFF demonstrations expected at several businesses in Phuthaditjhaba C (Phuthaditjhaba, Free State) from November 2020 owing to demand for UIF TERS funds - risks to business operations foreseen
- Strike action and/or demonstrations expected at AMSA operations in Vanderbijlpark (Gauteng) from November 2020 owing to demand for wages - risks to business operations foreseen
- EFF protest march expected in Kraaifontein (Cape Town, Western Cape) on 27/11/2020 owing to several grievances - travel and security risks foreseen
- EFF demonstrations expected at/near Brackenfell High School (Brackenfell, Cape Town, Western Cape) from 27/11/2020 owing to several grievances - travel and security risks foreseen
- Demonstrations expected at the Parliament of South Africa (Cape Town Central, Western Cape) on 28/11/2020 owing to dissatisfaction with GBV - risks to business operations foreseen
- Labour related grievances to result in industrial action at Algoa Bus Company operations in Nelson Mandela Bay Metropolitan Municipality (Eastern Cape) from November 2020 - operational risks foreseen
- Demonstrations anticipated at the Bishop Lavis Magistrate Court (Bishop Lavis, Cape Town, Western Cape) on 30/11/2020 during court proceedings of murder accused - travel and security risks expected
- Demand for adequate service delivery expected to result in protest action in Langa (Cape Town, Western Cape) from November 2020 - operational risks foreseen
- EFF protest march to Alexandra Police Station (Alexandra, Johannesburg, Gauteng) anticipated on 28/11/2020 owing to dissatisfaction with crime - risks to business operations foreseen
- Unrest relating to dissatisfaction with crime expected in several areas between Booyens Park (Bethelsdorp) and Port Elizabeth (Eastern Cape) from November 2020 - risks to travel and security foreseen
- #PutSouthAfricansFirst protest march expected in Johannesburg Central and Newtown (Johannesburg, Gauteng) on 27/11/2020 - risks to business operations anticipated
- Recurring electricity disruptions in Soshanguve (Gauteng) expected to result in protest action from November 2020 - travel and security risks expected
- Service delivery related protest action anticipated in Masakaneng (Groblersdal, Limpopo) from November 2020 - travel and security risks foreseen on the N11
- Dissatisfaction with removal of illegal electricity connections to result in protest action in Zandspruit 191 - IQ (Roodepoort, Gauteng) from November 2020 - travel and security risks foreseen
- Protest action anticipated in Somerset East, Cookhouse and Bedford (Eastern Cape) from November 2020 owing to the demand for employment opportunities - risks to business operations foreseen
- Demonstrations expected in Hammanskraal (Gauteng) from November 2020 following multiple drowning incidents - risks to business operations foreseen
- SAMWU industrial action at the Office of the Acting Director of Corporate Service of Nelson Mandela Bay Metropolitan Municipality (Port Elizabeth Central, Eastern Cape) from November 2020 - operational risks foreseen
- EPWP strike action underway in eThekweni Metropolitan Municipality (KwaZulu-Natal) owing to demand for insourcing - probable demonstrations from November 2020 to result in risks to business operations
- Demonstrations anticipated at RTMC in Eco-Park Estate (Centurion, Gauteng) from November 2020 owing to probable retrenchments - risks to travel and security foreseen
- Increased incidents of attacks on buses expected in several areas in Cape Town (Western Cape) from November 2020 - risks to business operations anticipated
- COSATU picket action expected at Shoprite Checkers Head Office (Brackenfell, Cape Town, Western Cape) on 30/11/2020 - travel and security risks anticipated
- EFF protest march to the Naledi Local Municipal Head Office in Vryburg (North West) anticipated on 27/11/2020 owing to several grievances - risks to travel and security foreseen
- Proposed Gauteng Township Economic Draft Bill expected to result in unrest in several areas in Gauteng from November 2020 - operational risks anticipated
- Grievances with Yethemba Local Municipality to result in protest action in Middelburg (Eastern Cape) from November 2020 - risks to travel and security foreseen
- Demonstrations anticipated at City of Tshwane Metropolitan Municipal Head Office in Pretoria Central (Gauteng) from November 2020 owing to the demand for reinstatement - risks to business operations foreseen
- CIAG protest march anticipated in Stellenbosch (Western Cape) on 05/12/2020 - travel disruptions and security risks foreseen
- Protest march against GBV to the Office of the Premier of Limpopo (Polokwane Central, Limpopo) expected on 03/12/2020 - risks to business operations foreseen
- Demonstrations anticipated at Bela-Bela Magistrate Court (Bela-Bela, Limpopo) on 07/12/2020 during court proceedings of murder suspect
- EFF demonstrations anticipated at Leopard Creek Country Club (Malelane, Mpumalanga) on 27/11/2020 - risks to business operations foreseen
- Court proceedings of murder accused expected to result in demonstrations at Wynberg Magistrate Court (Wynberg, Cape Town, Western Cape) on 03/12/2020 - operational risks anticipated
- ATDF protest action owing to dissatisfaction with foreign nationals anticipated in KwaZulu-Natal, Gauteng, Mpumalanga and Free State from November 2020 - risks to business operations expected
